


HOW TO REGISTER FOR YOUR AFFILIATE ACCOUNT



Request for Taxpayer Identification Number and Certification

Go to www.irs.gov/FormW9 for instructions and the latest information.

Give Form to the requester. Do not send to the IRS.

1 Name (as shown on your income tax return). Name is required on this line; do not leave this line blank.

2 Check appropriate box for federal tax classification of the person whose name is entered on line 1. Check only one of the following seven boxes.

3 Exemptions (codes apply only to certain entities, not individuals; see instructions on page 3):

Part I Taxpayer Identification Number (TIN)

Enter your TIN in the appropriate box. The TIN provided must match the name given on line 1 to avoid backup withholding. For individuals, this is generally your social security number (SSN). However, for a resident alien, sole proprietor, or disregarded entity, see the instructions for Part I, later. For other entities, it is your employer identification number (EIN). If you do not have a number, see *How to get a TIN*, later.

Part II Certification

Under penalties of perjury, I certify that:

1. The number shown on this form is my correct taxpayer identification number (or I am waiting for a number to be issued to me); and

2. I am not subject to backup withholding because: (a) I am exempt from backup withholding, or (b) I have not been notified by the Internal Revenue Service (IRS) that I am subject to backup withholding as a result of a failure to report all interest or dividends, or (c) the IRS has notified me that I am no longer subject to backup withholding; and

3. I am a U.S. citizen or other U.S. person (defined below); and

4. The FATCA code(s) entered on this form (if any) indicating that I am exempt from FATCA reporting is correct.

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Future developments. For the latest information about developments related to Form W-9 and its instructions, such as legislation enacted after they were published, go to www.irs.gov/FormW9.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.

Type in your full legal name, check off individual, address, social security, signature and date. Save it on your computer as a pdf. Print it out and sign it. Now if you have a scanner, scan it to your desktop on your computer, otherwise you can take a photo of it from your camera on your phone.

*If you are registering on your phone then use one of the softwares that will enable you to sign it. Date it and save a picture of it.

Now upload it back to the system.

Fantastic you have registered as an Affiliate and we are so glad to have you join us. The next step is to connect your PayPal to your Affiliate Account so you can get paid.

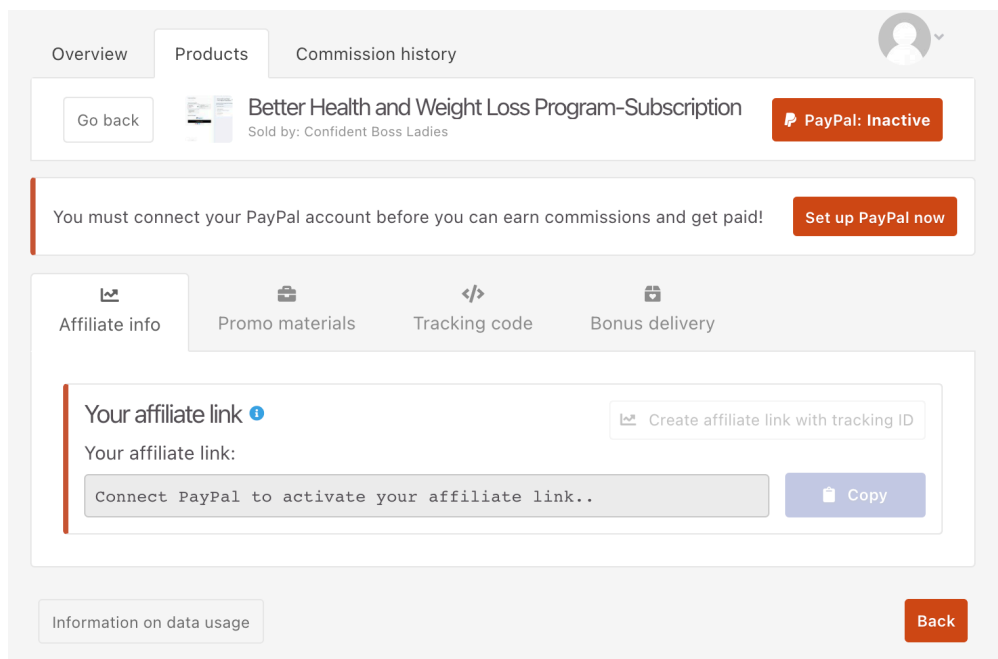

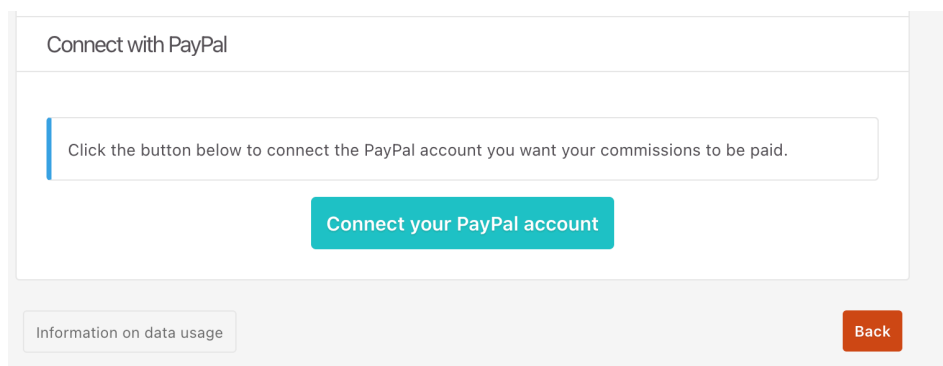

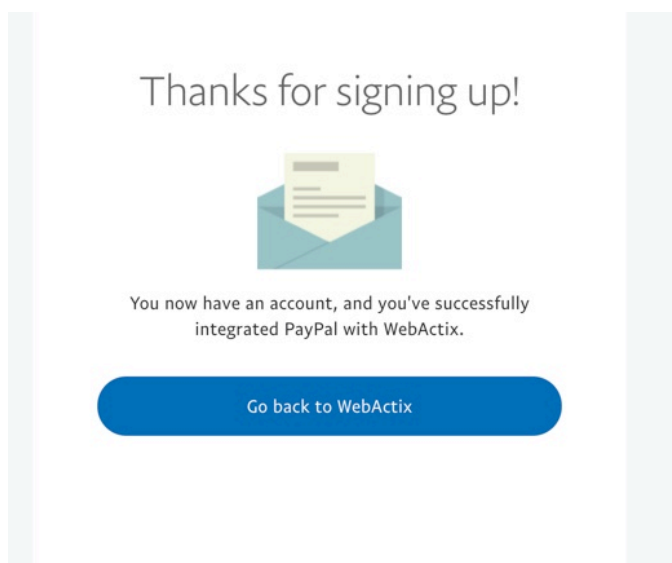
Click on Better Health and Weight Loss Program-Subscription



This page will open. Its now time to connect your PayPal account. Click on Set up PayPal now.

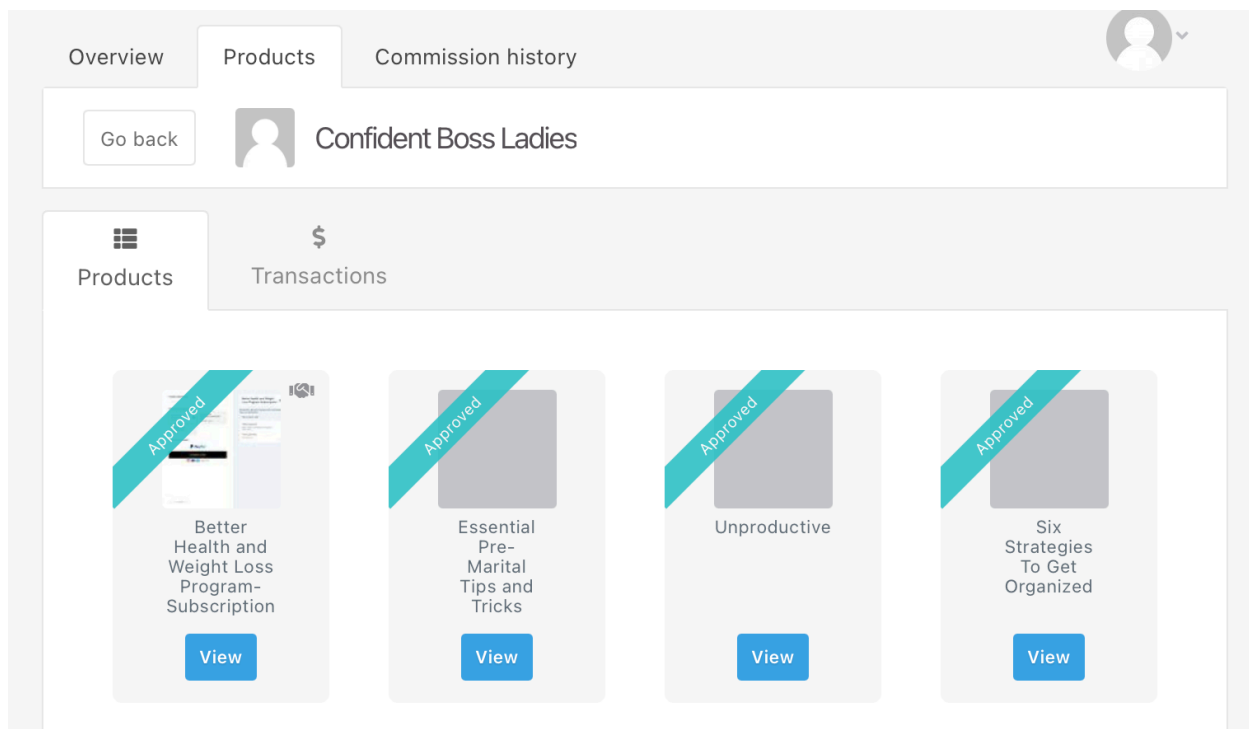


Paypal is going to ask you to upgrade your PayPal account to a business account. If you don't have a business name just type in your name as the business. Make sure when upgrading to a business account you add "Individual". For the type of business "Schools and Educational Services" . Finish the process with your information.



*You will know your PayPal is connected once you see the "Thanks for signing up!"

Click on blue button.



After you have connected your PayPal account just click on “Products” at the top. Click on the Better Health and Weight Loss Product

In order for your account to be active go to your email and confirm with PayPal. Sometimes this takes 10 min or so don't get frustrated. Until you click on the email your account will NOT be activated.

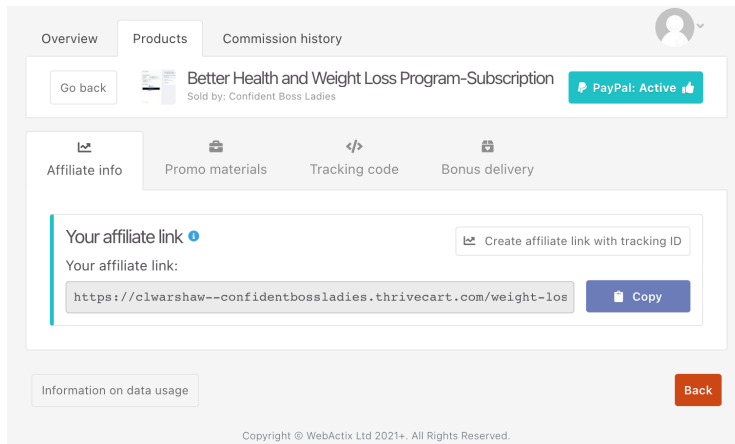

Log out of the affiliate software from Thrivecart and log back in. But before you do save the login screen on your browsers toolbar for easy access.

Click on Better Health and Weight Loss Program

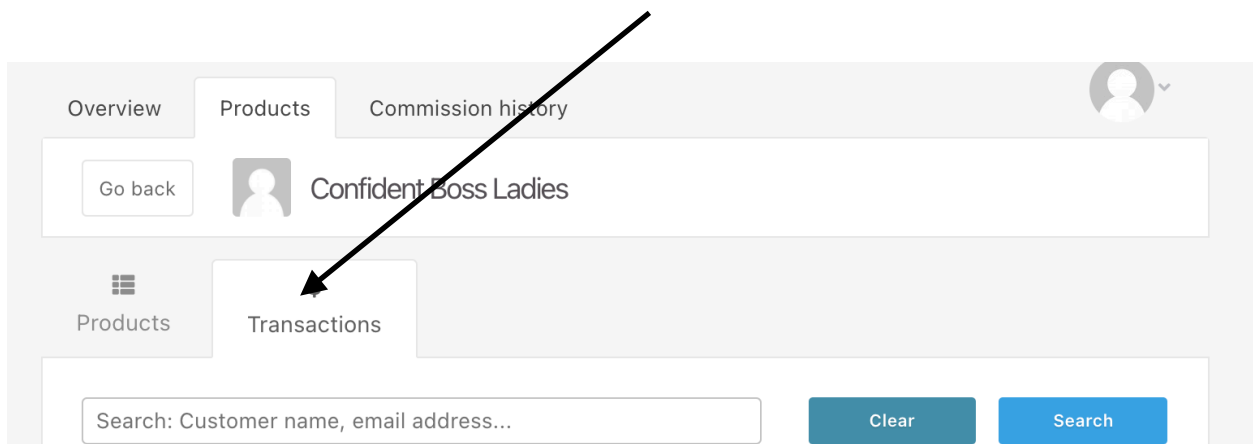
Click on “Copy” to get your affiliate link. Now where ever you want to promote this product you will always use your affiliate link. In my case it is
